- 4. Consideration and approval of minutes of November 4, 2019.
  Commissioner Kelton moved that the minutes of the
  November 4, 2019 meeting be approved, as presented by County Clerk
  Sharon Ferguson. Commissioner Worley seconded the motion and the
  Court voted 5-0 to approve.
- Presentation of Treasurer's/Auditor's Report.
   The November 12, 2019 Combined Statement Of Cash Position was presented by County Treasurer Ann Krpoun, for filing. (Exhibit #1)

The Total Of Funds Under The Care & Custody Of Brown County Treasurer And Auditor's Report, for October, 2019, was approved after a motion by Commissioner Worley and a second by Commissioner Shaw. The Court voted 5-0 to approve. An Affidavit, with the Report attached, was signed and prepared for publication, according to Section 114.026 of the Texas Local Government Code. (Exhibit #2)

- 6. Consideration and approval of payment of any bills needed.
  Commissioner Traweek moved that the claims, as presented by Assistant County Auditor Josie Contreras, be paid. Commissioner Shaw seconded the motion and the Court voted 5-0 to approve.
  (Exhibit #3)
- 7. Consideration and Approval of all appropriate action regarding the following:
  - A. Dr. Paul Lilly, Brown County Judge-Consideration and possible approval of 2020 Brown County Indigent Defense Grant Program Participation Resolution.

Judge Lilly moved that the Court approve the 2020 Brown County Resolution Indigent Defense Grant Program and authorize him to sign the Resolution. Commissioner Shaw seconded the motion and the Court voted 5-0 to approve. (Exhibit #4)

B. Mr. Joel Kelton, Commissioner Pct. 2-Consideration and possible approval to amend the contract between Brown County and Lifeguard Ambulance Service as recommended by unanimous vote by the EMS Advisory Committee.

After discussion, with Chris Furry, Chief of LifeGuard Ambulance Service, Commissioner Kelton moved that the Court approve to amend the contract, between Brown County, Texas and LifeGuard Ambulance Service, to allow for three full time fully staffed MICU units (Mobile Intensive Care Unit) and a fourth truck to be MICU 80% of the time and to be BLS (Basic Life Support), up to 15% of the time with a 5% buffer,

for unforeseen circumstances. This will allow the BLS truck to treat and transport, within its capabilities. LifeGuard will give Reports, at the Ambulance Advisory meetings, for transparency. Commissioner Worley seconded the motion and the Court voted to 4-1 to approve. (Exhibit #5)

C. Mr. Joel Kelton, Pct. 2-Consideration and possible approval to renew contract between Brown County and Lifeguard Ambulance Service subject to the approval of the other entities involved.

After discussion, Commissioner Kelton moved that the Court approve to renew the contract, between Brown County, Texas and LifeGuard Ambulance Service, (the Court believes that LifeGuard has substantially exceeded the minimum requirements of the contract during the previous one year term) subject to the approval of the other entities involved, for a term beginning January 1, 2021 through December 31, 2021, with no changes in the subsidy. Commissioner Worley seconded the motion and the Court voted 4-1 to approve. Judge Lilly voted nay.

D. Mr. Joel Kelton, Commissioner Pct. 2-Consideration and possible approval of action regarding burn ban.

After discussion, no action was taken. The burn ban remains in effect.

E. Mr. Larry Traweek, Commissioner Pct. 4-Consideration and possible approval of an application to install private line at 2 separate locations on CR 198 by Brookesmith SUD.

Commissioner Traweek moved that the Court approve two applications, made by Brookesmith SUD, to install buried water lines on County Road #198, in Precinct #4; subject to Brown County specifications for boring a road.
