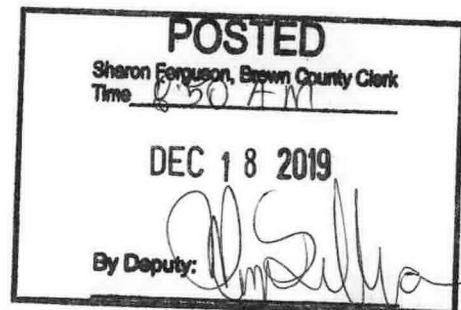


**The December 23, 2019 combined Statement Of Cash Position was presented by County Treasurer Ann Krpoun, for filing. (Exhibit #2)**


**F. Adjournment or recess.**


