

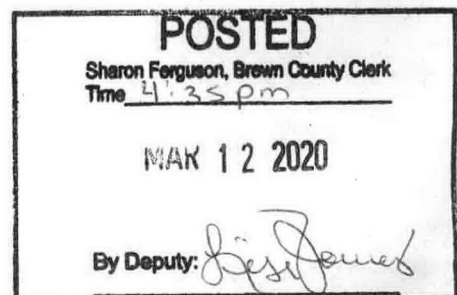

**After discussion, Commissioner Shaw moved that the Court authorize Brown County Clerk Sharon Ferguson to sign a County Acceptance contract between Brown County and Kofile Technologies, for back file imaging and indexing (archival digitization) 179 County Clerk land volumes 244 through 422. This project will cost approximately \$208,984.52 and will be funded from the County Clerk Records Archive Fund using GSA, an approved state contract. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve. (Exhibit #14)**

**G. Jennifer Robison, County Auditor-Consideration and possible approval of 2019 Year End budget adjustments (spon cj).**

**Commissioner Worley moved that the Court approve the 2019 Year End Budget Adjustments as presented for filing by Brown County Auditor Jennifer Robison. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve. (Exhibit #15)**

**H. Doug Hurt, JP Pct 1-Consideration and possible approval of declaring shredder surplus equipment (spon cj).**

**Commissioner Shaw moved that the Court declare a shredder and a printer, used in the Justice of the Peace Offices, as surplus. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve. (Exhibit #16)**
