Dave Fair led the Court in the invocation.

3. Citizens Comments

There were no citizen comments.

- 4. Consideration and approval of minutes of May 18th, 2020.

 Commissioner Worley moved that the minutes of the May 18, 2020 meeting be approved, as presented by Chief Deputy County Clerk Yolanda Bernal. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve.
- Consideration and approval of any Treasurer's/Auditor's Report.
 The May 26, 2020 Combined Statement Of Cash Position was presented by County Treasurer Ann Krpoun, for filing. (Exhibit #1)
- 6. Consideration and approval of payment of any bills needed.

 Commissioner Worley moved that the claims, as presented by Assistant County Auditor Josie Contreras, be paid. Commissioner Traweek seconded the motion and the Court voted 5-0 to approve. (Exhibit #2)

- 7. Consideration and approval of all appropriate action regarding the following:
 - A. Dr. Paul Lilly, Brown County Judge-Consideration and possible approval of Plexiglas installation in the district courtroom.

Judge Lilly moved that the Court approve the purchase and installation of 11 stand alone Plexiglas shields in the District courtroom. The work will be done by Early Glass & Brownwood Door, for \$4,684.00, and will be paid for from COVID-19 Funds. Commissioner Kelton seconded the motion and the Court voted 5-0 to approve. (Exhibit #3)

B. Dr. Paul Lilly, Brown County Judge-Consideration and possible approval of upgrades to security installation at front entrance.

Judge Lilly read two proposals for installation of security upgrades at the front entrance of the Courthouse. The proposals were from Bryan Baccus, for \$4,250.00 and McMillian Rustic Furniture, for \$3,950.00. After discussion, Commissioner Worley moved that the Court approve the proposal, from Bryan Baccus, for \$4,250.00, to build a front entry security desk and to install a secured lock box in the existing cabinet plus Mr. Baccus has agreed to install glass on the length of the cabinet at no extra charge. Commissioner Traweek seconded the motion and the Court voted 4-1 to approve. Commissioner Shaw voted nay. (Exhibit #4 and Exhibit #5)

C. Dr. Paul Lilly, Brown County Judge-Discussion and possible action regarding TAC Group Health renewal review presented by Bart Johnson.

Bart Johnson, representing Brown County's TAC Group Health, and Customer Service Representative Jana Brown, discussed the Brown County TAC Plan Options & Differences for the 2020-2021 Plan Year for Brown County employee health insurance. After discussion, no action was taken. (Exhibit #6)
