Department-Update on COVID19 response and County health
initiatives (Spon Pct. 2)

After an update, from Lisa Dick, Administrator of the Brownwood Brown County Health Department, concerning the COVID-19 outbreak, no action was taken.

F. Darrell Johnston, Emergency Management Coordinator-Consideration and possible approval of action regarding the purchase of 3 backpack and 4 portable handheld sprayers to be used on County properties and vehicles for disinfecting per CDC COVID-19 guidelines (Spon CJ).

After discussion, with Darrell Johnston, Emergency Management Coordinator, Commissioner Worley moved that the Court approve the purchase of three (3) Victory cordless electrostatic backpack sprayers and four (4) Victory cordless electrostatic portable handheld sprayers, as long as COVID Funds are available to pay for them, to be used on County properties and vehicles for disinfecting per CDC COVID-19 guidelines. The purchase price, of \$8,148.52, will be paid for using COVID-19 Funds. Commissioner Shaw seconded the motion and the Court voted 5-0 to approve. (Exhibit #6)

Darrell Johnston, Emergency Management CoordinatorConsideration and possible approval of action regarding permission to request County fuel/Service truck to be available as an on-call resource to provide fuel for fire department vehicles during prolonged wildfire events or other county emergency responses (Spon CJ).

After discussion, with Darrell Johnston, Emergency Management Coordinator, no action was taken.
