E. Vance Hill, Sheriff-Consideration for clarification and possible action on the Scope of Work proposal with the LCRA (Spon CJ).

After discussion, with Sheriff Vance Hill, Commissioner Kelton moved that the Court approve the Additional Services Proposal on the Scope of Work, with the Lower Colorado River Authority, for the county wide radio project. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve. (Exhibit #4)

The Texas Commission On Jail Standards Jail Population Report was presented by the Sheriff's Department, for filing. (Exhibit #5)

F. Jennifer Robison-Auditor-Eric Macha with Hilltop Securities-Presentation on infrastructure improvements financing options (Spon CJ).

After discussion, with Eric Macha, with Hilltop Securities, no action was taken.

G. Jennifer Robison-Auditor-Consideration and possible approval of financing for infrastructure improvements (Spon CJ).

After discussion, with Eric Macha, with Hilltop Securities, Commissioner Kelton moved that the Court authorize Hilltop Securities to seek bids for 2 million dollars in tax notes, to be payable in five (5) years. H. Gary Worley, Commissioner Pct. 1-Consideration and possible approval of employee changes (Spon Pct 1).

Commissioner Worley moved that he be authorized to hire Harold Sellers as a temporary full-time employee, effective October 5, 2020, for a road hand in Precinct #1. Mr. Sellers will be paid \$12.00 per hour from COVID Funds. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve. (Exhibit #8)

 Wayne Shaw, Commissioner Pct. 3-Consideration and possible approval of employee changes (Spon Pct 3).

Commissioner Shaw moved that he be authorized to hire Ben Hutchins as a temporary full-time employee, effective September 29, 2020, for a road hand in Precinct #3 and to hire Terry Browder as a temporary full-time employee, effective October 5, 2020, for a road hand in Precinct #3. Mr. Hutchins and Mr. Browder will each be paid \$12.00 per hour from COVID Funds. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve. (Exhibit #9 and Exhibit #10)
