If you cannot find the third trustee, then the Commander must attach a letter stating why the third trustee is not available.

Don't forget to pay for you post Delegate/New members fees and turn in the post Delegate Election report for your post. You have until 15 days prior to convening of the State Convention to pay for your delegate/new member fees. Currently the date the payments must be at Dept. is June 2nd.
