Sr. Chaplain Dave Fair led the Court in the invocation.

3. Citizens Comments

There were no citizen comments.

4. Consideration and approval of minutes of October 5th, 2020 meeting.

Commissioner Shaw moved that the minutes of the October 5, 2020 meeting be approved, as presented by County Clerk Sharon Ferguson. Commissioner Traweek seconded the motion and the Court voted 3-0 to approve.

Consideration and approval of any Treasurer's/Auditor's Report.
 The October 13, 2020 Combined Statement Of Cash Position was presented by County Treasurer Ann Krpoun, for filing. (Exhibit #1)

The Total Of Funds Under The Care & Custody Of Brown County Treasurer And Auditor's Report For September 2020 was approved after a motion by Commissioner Shaw and a second by Commissioner Traweek. The Court voted 3-0 to approve. An Affidavit, with the Report attached, was signed and prepared for publication, according to Section 114.026 of the Texas Local Government Code. (Exhibit #2)

- 6. Consideration and approval of payment of any bills needed.

 Commissioner Traweek moved that the claims, as presented by Assistant County Auditor Josie Contreras, be paid. Commissioner Shaw seconded the motion and the Court voted 3-0 to approve. (Exhibit #3)
- 7. Consideration and approval of all appropriate action regarding the following:
 - A. Joel Kelton, Commissioner Pct. 2-Consideration and possible approval of action regarding burn ban.

After discussion, no action was taken. The burn ban remains lifted.

B. Lisa Dick, Administrator, Brownwood-Brown County Health Department-Update on COVID19 response and County health initiatives (Spon p2).

After an update, from Lisa Dick, Administrator of the Brownwood-Brown County Health Department, concerning the COVID-19 outbreak, no action was taken.

C. Joel Kelton, Commissioner Pct. 2-Consideration and possible approval of action regarding an Application to install a Private Line on CR 415 (Spon p2).

Commissioner Kelton moved that the Court approve an application, made by Tejas Petroleum Resources, LLC, to install a buried water line within the right-of-way of County Road #415, in Precinct #2; subject to Brown County specifications for cutting a road. Commissioner Traweek seconded the motion and the Court voted 3-0 to approve. (Exhibit #4)

D. Roy Parrack, Constable Pct. 3-Consideration and possible approval of action regarding Constable Fee Schedule for 2021 (Spon CJ).

After discussion, with Roy Parrack, Brown County Constable Precinct #3, Commissioner Traweek moved that the Court approve the Proposed Brown County Constables' Fees for 2021, with no changes. Commissioner Shaw seconded the motion and the Court voted 3-0 to approve. (Exhibit #5)

E. Vance Hill, Sheriff-Consideration and possible approval of action regarding Sheriff's Department Fee Schedule for 2021 (Spon CJ).

After discussion, with Vance Hill, Brown County Sheriff, Commissioner Shaw moved that the Court approve the Proposed Brown County Sheriffs' Fees for 2021, with two changes. The changes are:

Housing Inmates – In County Holding (per day/per head) from \$25.00 to \$35.00

Housing Inmates – Out-of-County Prisoners (per day/per head) from \$45 to \$50.00

Commissioner Traweek seconded the motion and the Court voted 3-0 to approve. (Exhibit #6)

The Texas Commission On Jail Standards Jail Population Report was presented by the Sheriff's Department, for filing. (Exhibit #7)

F. Joel Kelton, Commissioner Pct. 2-Consideration and possible approval of action regarding the reopening of local bars following Governor Abbott's Executive Order to Open Bars in Qualifying Counties (Spon p2).

After discussion, Commissioner Shaw moved that the Court approve a Resolution Re-Opening Bars And Similar Establishments up to 50% capacity beginning October 14, 2020. Commissioner Traweek seconded the motion and the Court voted 3-0 to approve. (Exhibit #8)
