

Commissioner Shaw seconded the motion and the Court voted 5-0 to approve.

E. Carl Greer, Maintenance-Consideration and approval of action regarding the liquidation of surplus items (Spon CJ).

After discussion, with Carl Greer, Brown County Maintenance Supervisor, Commissioner Worley moved that the Court declare, as surplus, various county items listed in Exhibit #7 and made a part of these Commissioner Court minutes.
