  motion and the Court voted 5-0 to approve. (Exhibit #2)

After discussion, no action was taken. The burn ban remains in effect.

After an update, from Lisa Dick, Administrator, from the Brownwood-Brown County Health Department, concerning the COVID-19 outbreak, no action was taken. (Exhibit #3)

Commissioner Shaw seconded the motion and the Court voted 5-0 to approve.

The Texas Commission On Jail Standards Jail Population Report was presented by the Sheriff's Department, for filing. (Exhibit #6)

D. Dale Cummings, Intersect Power-Presentation of IP Radian Solar Project, consideration and discussion of possible approval of tax abatement (Spon CJ).

After discussion, and a video presentation, from Dale Cummings, Senior Consultant for Cummings Westlake LLC, and Christian Fiene, Principal, for Intersect Power, concerning a Radian Solar Project and possible tax abatement, no action was taken. (Exhibit #7)

E. Sharon Ferguson, County Clerk-Consideration and possible approval of Bond for Tax Assessor Collector (Spon CJ).

After discussion, Judge Lilly moved that the Court approve the bond for the Tax Assessor-Collector, Christine Pentecost. The new surety bond will be filed with the Comptroller Of Public Accounts and will cover state taxes and registration fees as required by Sections 6.28 and 6.29 of the Texas Tax Code. After discussion, Commissioner Kelton moved that the Court approve out of state travel, for Judge Lilly, to attend COVID Vaccine training. Commissioner Shaw seconded the motion and the Court voted 3-2 to approve. Commissioner Worley and Commissioner Traweek voted nay.

After discussion, Commissioner Kelton moved that the Court approve reimbursement for out of state travel, for Judge Lilly, to attend COVID Vaccine training, using COVID Funds, if available. Commissioner Worley noted that he was not against the travel reimbursement if the costs could be paid from COVID Funds.
