After discussion, with Brown County Jail Captain Les Karnes, Commissioner Kelton moved that the Court authorize the Sheriff's Department to enter into a four year contract with CTC Company, Inc., (City Tele-Coin Company, Inc.), for the inmate telephone system. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve. (Exhibit #4)

The Texas Commission On Jail Standards Jail Population Report was presented by the Sheriff's Department, for filing. (Exhibit #6)

H. Matthew Krischke, Director of IT-Consideration and possible action regarding declaring a surplus of equipment to be sold or disposed of (Spon CJ).

Judge Lilly moved that the Court declare, as surplus, equipment from the IT Department, as presented by Brown County Auditor Jennifer Robison. The list of non-working surplus equipment will be destroyed and the list of working surplus equipment will be sold on Govdeals. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve. (Exhibit #7 and Exhibit #8)

I. Larry Franks, Elections Administrator-Consideration and possible approval of out of state travel for Larry Franks and Brenda Arp for Fiscal year 2021 (Spon CJ).

Commissioner Shaw moved that the Court authorize Elections
Administrator Larry Franks and Assistant Elections Administrator
Brenda Arp to travel out of state, for training, for Fiscal Year 2021.
Commissioner Traweek seconded the motion and the Court voted 4-0 to approve.

J. Larry Franks-Approval of Budget Amendment to Fiscal Year 2021 Elections Budget for travel and training. Add additional \$9,000 to cover additional training. Budget will increase from \$7,000 to \$16,000.

Commissioner Shaw moved that the Court approve to add an additional \$9,000.00, to the Elections Office Budget, for travel and training for Fiscal Year 2021. Commissioner Kelton seconded the motion and the Court voted 4-0 to approve.

J. Gary Worley, Commissioner Pct. 1-Consideration and possible approval of action regarding employee changes (Spon Pct. 1).

Commissioner Traweek moved that the Court approve the Temporary hire of Chad Hallum, as a Precinct #1 Road Crew Hand, to be paid \$12.00 per hour, from COVID Funds, beginning November 30, 2020. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve. (Exhibit #9)

K. T'Anna McClure, Commissioners Executive Administrative Assistant-Consideration and possible approval of action regarding proposed holiday schedule for the 2021 fiscal year (Spon CJ).

Commissioner Kelton moved that the Court approve the Proposed Brown County Holidays For Calendar Year 2021, as presented by T'Anna McClure, Commissioner Court Executive Administrative Assistant. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve. (Exhibit #10)

After discussion, with Brown County Treasurer Ann Krpoun, Commissioner Kelton moved that the Court adopt a Resolution Of The Commissioners Court, Brown County, Texas Adopting The Investment Policy. The Court acknowledges that an investment policy must be adopted to comply with the Public Funds Investment Act, Government Code 2256, and as required by the Public Funds Investment Act, the Court must approve the investment policy on an annual basis. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve. (Exhibit #11)
