Wayne,

This morning in our conversation you said that you had grown up with many of the Brookesmith people and you could not be the one to say no to them and their kids for the "life changing" amount of money being offered by the solar project. You also said that you could not be the one to say no to a person with 130 acres who had a chance to make a lot of money for the next 20 years. You said that you were going to vote yes on the requested tax abatements. I reminded you that a strong majority of the voters in your precinct wanted you to vote no. They were opposed to tax abatements for renewable energy and also felt more harm than benefit would be realized for them and the County. You told me that their wishes didn't matter. You also said that the project wouldn't hurt me and that you just wanted to be friends with everyone.

You took on the ethical and moral obligation to represent the wishes of the voters of your precinct when you accepted the position. You accepted the voters (taxpayers) money for your salary, health and retirement benefits. Now you are unwilling to honor the wishes of a strong majority of the same people that you pledged to represent.

By your own words, you have admitted that you have a conflict of interest and are unwilling to represent the wishes of the voters of your precinct. You admit that you cannot set aside your personal feelings on this issue. Your refusal to represent the wishes of the voters in your precinct is abdication of the duties of your office.

In fairness to the voters of Precinct 3, you should immediately resign. This would allow a replacement to properly represent the voters of the precinct. At the very least, you should recuse yourself from voting on or even discussing the proposed abatement. State law requires recusal when a conflict is present.
