 motion and the Court voted 5-0 to approve. (Exhibit #2)

After discussion, no action was taken. The burn ban remains lifted.

C. Vance Hill, Sheriff-Consideration and possible approval of action regarding accepting donations made to the Brown County Sheriff's Department. (CJ)

After discussion, with Chief Deputy Sheriff Becky Caffey, Commissioner Worley moved that the Sheriff's Department be authorized to accept a \$80.00 donation, from Blevins Body Shop. Commissioner Traweek seconded the motion and the Court voted 5-0 to approve.

D. Wayne Shaw, Commissioner Pct. -Consideration and possible approval of action regarding application to Install a Private line by Zephyr WSC on CR 270.

Commissioner Shaw moved that the Court approve an application, made by Zephyr Water Supply, to install a buried water line within the right-of-way of County Road #270, in Precinct #3, subject to Brown County specifications. Commissioner Kelton seconded the motion and the Court voted 5-0 to approve. (Exhibit #6)

E. Josh Martin, Bangs ISD-Consideration and possible approval of action regarding funding broadband and COVID mitigation for Bangs ISD out of the American Rescue Plan Act up to the sum of \$250,000. (10 minutes)

After discussion, with Bangs ISD Assistant Superintendent Truman Westfall and Bangs ISD IT Director Chris Thompson, no action was taken. (Exhibit #7)

F. Steve Mickleson, Brookesmith ISD-Consideration and possible approval of action regarding funding broadband and COVID mitigation for Brookesmith ISD out of the American Rescue Plan Act up to the sum of \$250,000. (10 minutes)

After discussion, with Brookesmith ISD Superintendent Steve Mickleson and Brookesmith ISD Principal Danny Copeland, no action was taken.

G. Dewayne Wilkins, Early ISD-Consideration and possible approval of action regarding funding broadband and COVID mitigation for Early ISD out of the American Rescue Plan Action up to the sum of \$250,000. (10 minutes)

After discussion, with Early ISD Superintendent Dewayne Wilkins, no action was taken.

H. Steve Adams, Brookesmith Water District-Consideration and possible approval of action regarding funding Brookesmith Water District for water infrastructure and sewer out of the American Rescue Plan Act for the sum of up to \$317,499. (10 minutes)

After discussion, with Steve Adams, from Brookesmith Water District, Commissioner Kelton moved that the Court authorize to expend a sum of up to \$317,499.00, from the American Rescue Plan Act Fund, to be used for water infrastructure and sewer, for the Brookesmith Water District. Commissioner Shaw seconded the motion and the Court voted 5-0 to approve.

I. Joel Kelton, May Water District-Consideration and possible approval of action regarding funding May Water District for water infrastructure and sewer out of the American Rescue Plan Act for the sum up to \$350,284. (10 minutes)

After discussion, with Joel Kelton, from May Water District, Commissioner Kelton moved that the Court authorize to expend a sum of up to \$350,284.00, from the American Rescue Plan Act Fund, to be used for water infrastructure and sewer, for the May Water District. Commissioner Shaw seconded the motion and the Court voted 5-0 to approve.

J. Richard Gist, Zephyr Water District-Consideration and possible approval of action regarding funding Zephyr Water District for water infrastructure and sewer out of the American Rescue Plan Act for the sum up to \$255,011. (10 minutes)

After discussion, with Terry Edgar, from Zephyr Water District, Commissioner Kelton moved that the Court authorize to expend a sum of up to \$255,011.00, from the American Rescue Plan Act Fund, to be used for water infrastructure and sewer, for the Zephyr Water District. Commissioner Shaw seconded the motion and the Court voted 5-0 to approve.

K. Michael Murray, District Attorney-Consideration and possible approval of action regarding approval of the use of the American Rescue Plan Act for technology for Brown County. (CJ) (10 minutes)

District Attorney Micheal Murray, Assistant District Attorney Alisha Bird, District Judge Mike Smith, and IT Manager Matt Krischke, addressed the Court concerning a county wide infrastructure upgrade, using the American Rescue Plan Act Funds. After discussion, with County Clerk Sharon Ferguson and District Clerk Cheryl Jones, no action was taken. (Exhibit #9 and Exhibit #10)

for a total of \$40,900.00. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve. Commissioner Worley abstained. (Exhibit #11)

N. Paul Lilly, County Judge-Consideration and possible approval of the transfer of American Rescue Plan Act grant funds from Brown County to the Center For Life Resources for their use in providing services \$41,021.83.

After discussion, with Joey Smith, from the Center For Life Resources, Commissioner Shaw moved that the Court approve the transfer of American Rescue Plan Act Funds, from Brown County, to the Center For Life Resources, in the amount of \$41,021.83 plus up to \$2,000.00 equipment cost, for a total of \$43,021.83, to be used to purchase a transport vehicle. Commissioner Traweek seconded the motion and the Court voted 5-0 to approve.
