C. Wayne Shaw, Commissioner Pct. 3-Consideration and possible approval of action regarding application to install a private line on CR 258 by Central Texas TeleCommunications. (CTTC)

Commissioner Shaw moved that the Court approve an application, made by Central Texas TeleCmmunications, to install a buried line within the right-of-way of County Road #258, in Precinct #3; subject to Brown County specifications for boring a road. Commissioner Traweek seconded the motion and the Court voted 5-0 to approve. (Exhibit #3)
