**Proposed Timeline  
For  
County Attorney  
Appointment**

- 1) 11-22-21 "resign to run" triggered by Shane Britton's announcement as a candidate for Brown County Judge. Leaving Mr. Britton serving as a Holdover in the office of County Attorney until a replacement is appointed by the Court.
- 2) During the Commissioners' Court meeting on 11-29-21 the Court declares the need for a Special Election for Brown County Attorney to be held at the time of the General Election on November 8, 2022.
- 3) After November 29, 2021, candidates for Brown County Attorney will have time to file for that office before the December 13, 2021 filing deadline.
- 4) After the March 2022 Primary the Court may choose to appoint the winner of the Primary if there is NO Democratic opponent.
