Judge Lilly declared a Quorum and called the meeting to order.

After discussion, Commissioner Kelton moved that the Court finds that circumstances present in all or part of the unincorporated area of the county create a public safety hazard that would be exacerbated by outdoor burning and that the Court sign an Order Prohibiting Outdoor Burning. Commissioner Traweek seconded the motion and the Court voted 5-0 to approve. (Exhibit #3)

Judge Lilly updated the Court concerning the COVID-19 response and County health initiatives. No action was taken.

C. Hon. Bryan Thompson-JP 3-Consideration and possible approval of action regarding Court Clerk Hire starting Nov. 22, 2021. (CJ)

- E. Joel Kelton, Commissioner Pct. 2-Consideration and possible approval of action regarding contract with Net Data/IP 3 Vertical. After discussion, Commissioner Kelton moved that the Court approve a three-year Master Agreement between i3 Verticals, LLC and Brown County for Annual Maintenance & Support/Hosting Services for software for Brown County, subject to determining the effective date of the agreement. Commissioner Shaw seconded the motion and the Court voted 4-1 to approve with Judge Lilly voting nay. (Exhibit #6)
