2. Prayer

Bryan Allen led the Court in the invocation.

3. Recognition of Special Guests and Presentations.

4. Citizens Comments

There were no citizen comments.

5. Consideration and approval of the agenda minutes from the previous meeting (s). 05-23-22 & 06-06-2022

Commissioner Kelton moved that the minutes of the May 23, 2022, and the June 6, 2022, meetings be approved, as presented by County Clerk Sharon Ferguson. Commissioner Shaw seconded the motion and the Court voted unanimously to approve. Commissioner Worley and Judge Lilly did not vote for the May 23, 2022, meeting because they were not present at the meeting.

6. Consideration and approval of any Treasurer's/Auditor's Report.

The June 13, 2022, Combined Statement Of Cash Position was presented by County Treasurer Ann Krpoun, for filing. (Exhibit #1)

The Total Of Funds Under The Care & Custody Of Brown County Treasurer And Auditor's Report For May 2022 was approved after a motion by Commissioner Worley and a second by Commissioner Traweek. The Court voted 5-0 to approve. An Affidavit, with the Report attached, was signed, and prepared for publication, according to Section 114.026 of the Texas Local Government Code. (Exhibit #2)

- 7. Consideration and approval of all appropriate action regarding the following:
 - A. Honorable Joel Kelton, Commissioner Pct. 2-Consideration and possible approval of action regarding burn ban.

After discussion, Commissioner Kelton moved that the Court re-instate the burn ban by signing an Order Prohibiting Outdoor Burning stating that circumstances present in all or part of the unincorporated area of the county create a public safety hazard that would be exacerbated by outdoor burning. Commissioner Shaw seconded the motion and the Court voted 5-0 to approve. (Exhibit #3)

B. Lisa Dick, Administrator-Brownwood/Brown County Health
Department-Update on COVID 19 response and County health
initiatives. (Pct. 2)

After an update, from Lisa Dick, Administrator of the Brownwood Brown County Health Department, concerning the COVID-19 outbreak, no action was taken.

C. Amanda Bundick, County Court at Law Court Coordinator-Consideration and possible approval to sale copy machine that is inoperable surplus on GovDeals.com. (CJ)

After discussion, with County Court at Law Court Coordinator, Amanda Bundick, Commissioner Kelton moved that the Court authorize her to list an inoperable copy machine, that was declared surplus, on GovDeals.com and if the copier does not sale, on GovDeals, then the copier can be scrapped. Commissioner Traweek seconded the motion and the Court voted 5-0 to approve.

D. Honorable Gary Worley, Commissioner Pct. 1-Consideration and possible approval of action regarding Section 130.908 of the Texas Local Government Code.

After discussion, Commissioner Kelton moved that the Office of the County Judge and County Judge Paul Lilly, who was not re-elected to office, not make expenditures exceeding \$2,500.00, per month, without Court approval, excluding salaries. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve. Judge Lilly abstained from voting, and he said he will surrender his county credit card to the Auditor. (Exhibit #4)

E. Honorable Gary Worley, Commissioner Pct. 1-Consideration and possible approval of action regarding adopting an order to regulate the use of certain fireworks for the July 4th fireworks season pursuant of Section 352.051 of the Texas Local Government Code.

Commissioner Worley moved that the Court adopt an Order Prohibiting Or Restricting Certain Fireworks in Unincorporated Areas Of Brown County, Texas, such as skyrockets with sticks or missiles with fins. Commissioner Kelton seconded the motion and the Court voted 5-0 to approve. (Exhibit #5)

F. Honorable Vance Hill, Sheriff-Consideration and possible approval of employee changes. (CJ)

After discussion, with Chief Deputy Becky Caffey, Commissioner Kelton moved that the Court authorize the following personnel change and salary in the Sheriff's Department:

Commissioner Traweek seconded the motion and the Court voted 5-0 to approve.

After discussion, with Chief Deputy Becky Caffey, Judge Lilly moved that the Court authorize the Sheriff's Department to accept a donation, of \$90.00, from Blevins Body Shop. Commissioner Kelton seconded the motion and the Court voted 5-0 to approve.
