The quotes were from Accurate Air Solutions and Black Plumbing. Commissioner Kelton moved that the Court approve the quote, from Black Plumbing, for the removal and replacement of the discharge water line at the Juvenile Justice Center. Commissioner Worley seconded the motion and the Court voted 5-0 to approve. (Exhibit #2 and Exhibit #3)
