 - A. Honorable Joel Kelton, Commissioner Pct. 2-Consideration and possible approval of action regarding reinstating burn ban.

After discussion, Commissioner Worley moved that the Court sign an Order Prohibiting Outdoor Burning due to circumstances present in all or part of the unincorporated area of the county create a public safety hazard that would be exacerbated by outdoor burning. Commissioner Shaw seconded the motion and the Court voted 5-0 to approve. (Exhibit #3)

B. Honorable Joel Kelton, Commissioner Pct. 2-Consideration and possible approval of action regarding financing of new equipment.

After discussion, Commissioner Kelton moved that the Court authorize him to finance \$238,822.00, with Citizens National Bank, for his newly purchased Motor Grader. This will be paid from Precinct #2 Funds. Commissioner Worley seconded the motion and the Court voted 5-0 to approve.
