 Commissioner Worley moved that the minutes of the September 6, 2022, meeting, and the minutes of the Public Workshop meeting for September 6, 2022, be approved, as presented by Chief Deputy County Clerk Amber Hanley. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve.

 The September 12, 2022, Combined Statement Of Cash Position was presented by County Treasurer Ann Krpoun, for filing. (Exhibit #1)

The Total Of Funds Under The Care & Custody Of Brown County Treasurer And Auditor's Report for August 2022 was approved after a motion by Commissioner Worley and a second by Commissioner Shaw. The Court voted 4-0 to approve. An Affidavit, with the Report attached, was signed, and prepared for publication, according to Section 114.026 of the Texas Local Government Code. (Exhibit #2)

After discussion, no action was taken. The burn ban remains lifted.

Judge Pro-Tem Kelton opened the Public Hearing on the preservation and restoration of the County Clerk's Archive Plan and asked for questions or comments, from the audience. There were none. Judge Pro-Tem Kelton closed the Public Hearing.

After discussion, Commissioner Worley moved that the Court sign an Order to adopt the County Clerk's Records Archival Plan/Fee, as presented by Chief Deputy County Clerk Amber Hanley. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve. (Exhibit #3)

Agriculture to assist with financing a home delivered meal program that provides meals to home bound persons in the County who are elderly and/or have a disability. Commissioner Worley seconded the motion and the Court voted 4-0 to approve. (Exhibit #5)

After discussion, with Chief Deputy Sheriff James Stroope, Commissioner Worley moved that the Court authorize the Sheriff's Department to accept an \$80.00 donation from Blevins Body Shop. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve.
