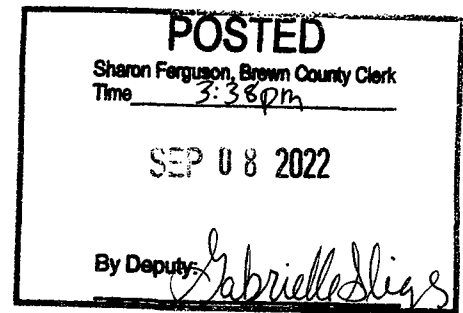


**Judge Pro-Tem Kelton announced, at 10:50 a.m. that the Court recess the Executive Session and reconvene into Open Session. No action was taken.**
