B. Darrell Johnston, EMC-Consideration and possible approval of action regarding the acceptance of a donation. (CJ)

Commissioner Kelton moved that the Court authorize the Brown County Chaplains Program to accept a \$300.00 check from the Knights of Columbus. Commissioner Shaw seconded the motion and the Court voted 3-0 to approve.

The purchase price, for the first year, of \$10,421.00, will be paid from the Sheriff Department's Operation Budget. Each year thereafter will be \$6,100.00. Judge Lilly seconded the motion and the Court voted 3-0 to approve.
