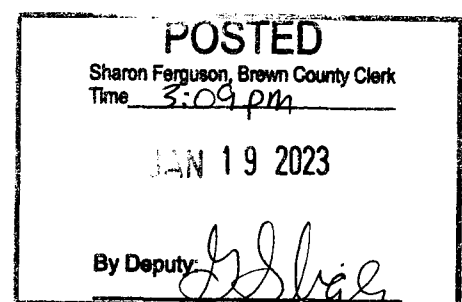


**The January 23, 2023, Combined Statement Of Cash Position was presented by County Treasurer Ann Krpoun, for filing. (Exhibit #1)**

**The Total Of Funds Under The Care & Custody Of Brown County Treasurer And Auditor's Report For December 2022 was approved after a motion by Commissioner Worley and a second by Commissioner Traweek. The Court voted 5-0 to approve. An Affidavit, with the Report attached, was signed, and prepared for publication, according to Section 114.026 of the Texas Local Government Code. (Exhibit #2)**

**7. Consideration and approval of all appropriate action regarding the following:**

**A. Honorable Joel Kelton, Commissioner Pct. 2-Consideration and possible approval of action regarding burn ban.**

**After discussion, no action was taken. The burn ban remains lifted.**

**B. Mia Stroope, Chief Justice-Court Administrator-Consideration and possible approval of purchasing new computer and updating to Windows 10. (CJ)**

**After discussion, with Bryan Thompson, Justice of the Peace Precinct #3, Commissioner Kelton moved that the Court authorize the purchase of two computers, (plus Windows updates) for the Justice of the Peace Offices. The total purchase price will be \$2,487.95 and will be paid from the Justice of the Peace Technology Fund. Commissioner Shaw seconded the motion and the Court voted 5-0 to approve.**

**C. Jennifer Robison, Auditor-Consideration and possible approval of action regarding declaring IT equipment working equipment surplus to sell on GovDeals. (CJ)**

**Commissioner Kelton moved that the Court declare IT equipment, that is working, as surplus to be sold. Commissioner Worley seconded the motion and the Court voted 5-0 to approve. (Exhibit #3)**

**Commissioner Kelton moved that the Court declare IT equipment, that is unusable, as surplus to be destroyed. Commissioner Shaw seconded the motion and the Court voted 5-0 to approve. (Exhibit #4)**

**E. Honorable Larry Traweek, Commissioner Pct. 4-Consideration and possible approval of action to purchase a Chipper.**

**Commissioner Traweek informed the Court that Precinct #2 (Joel Kelton) and Precinct #4 (Larry Traweek) share a Chipper. He said that Precinct #2 Commissioner (Joel Kelton) will pay Precinct #4 Commissioner (Larry Traweek) one half of the value, which is \$19,000.00 of the shared Chipper so that Precinct #4 (Larry Traweek) can purchase a new Chipper to be used in Precinct #4. After discussion, Commissioner Traweek moved that he be authorized to purchase a Chipper for \$81,277.00. Of that amount, he will finance \$62,277.00 with Texas Bank. Commissioner Shaw seconded the motion and the Court voted 5-0 to approve. (Exhibit #5)**






