

The Brown County Commissioners Court convened in a Regular meeting June 12, 2023, at 9:00 A.M. in the Commissioner's Courtroom, at the Brown County Courthouse, 200 South Broadway St., Brownwood, Texas.

I. DECLARE A QUORUM AND CALL MEETING TO ORDER

The meeting is recorded and can be found on the Brown County Texas website.

Judge Britton declared a Quorum and called the meeting to order.

The June 12, 2023, Combined Statement Of Cash Position was presented by County Treasurer Ann Krpoun, for filing. (Exhibit #1)

The Total Of Funds Under The Care & Custody Of Brown County Treasurer And Auditor's Report For May 2023 was approved after a motion by Commissioner Kelton and a second by Commissioner Traweek. The Court voted 3-0 to approve. An Affidavit, with the Report attached, was signed, and prepared for publication, according to Section 114.026 of the Texas Local Government Code. (Exhibit #2)

VII. RESOLUTIONS AND PRESENTATIONS:

A. ALERT Training Resolution – Consider and take appropriate action to approve a resolution authorizing Brown County to apply for grant funding for ALERRT Training. To be presented by Pat McLaughlin.

After discussion, with Grants Coordinator Pat McLaughlin, Commissioner Traweek moved that the Court approve a Resolution authorizing Brown County to apply for grant funding, to the Office of the Governor, for ALERRT Training. Commissioner Kelton seconded the motion and the Court voted 3-0 to approve. (Exhibit #3)

A. Consideration and possible approval of action to declare county property as surplus equipment and authorize selling of the property. To be presented by Precinct 4

Commissioner Larry Traweek,

After discussion, Commissioner Traweek moved that a list of items, (see attached list) from Precinct #4, be declared as surplus to be sold on Govdeals.com. Commissioner Kelton seconded the motion and the Court voted 3-0 to approve. (Exhibit #4)

After discussion, Commissioner Kelton moved that the Court approve updating the Brown County Credit Card Policy to remove the previous County Judge and add the current County Judge Shane Britton. Commissioner Traweek seconded the motion and the Court voted 3-0 to approve. (Exhibit #5)

D. PUBLIC HEARING TO ADOPT COUNTY REGULATIONS

AMENDING OSSF RULES – Consideration and possible action to adopt an order allowing homeowners, with on-site sewage facilities requiring periodic maintenance, who attend and complete an approved course to maintain their own systems. To be presented by Rita Thompson.

Judge Britton closed the Regular Session and opened the Public Hearing to adopt county regulations amending OSSF rules and asked the public for comments or questions. There were none. Judge Britton closed the Public Hearing and called the Regular Session back to order. After discussion, with Brown County DR Inspector Rita Thompson, Commissioner Traweek moved that the Court sign an Order Adopting Rules Of Brown County, Texas For On-Site Sewage Facilities that will allow homeowners, with on-site sewage facilities requiring periodic maintenance, to attend and complete an approved course to maintain their own sewage system. Commissioner Kelton seconded the motion and the Court voted 3-0 to approve. (Exhibit #6) (Exhibit #6a TECQ Approval)

E. Consideration and possible approval of bids for removal and re-installation of vinyl plank flooring for the Elections

Office.

The Court received three (3) estimates for removal and re-installation of vinyl plank flooring, that was damaged by recent flooding, for the Election's Office. The estimates were from:

R G's Pro Floors - \$14,880.00 (Exhibit #7)

Heart of Texas Flooring LLC. - \$14,984.53 (Exhibit #8)

Jones Carpets - \$17,790.21 (Exhibit #9)

After discussion, Commissioner Kelton moved that the Court approve the estimate, from R G's Floors, for \$14,880.00. Commissioner Traweek seconded the motion and the Court voted 3-0 to approve.

Commissioner Kelton moved that the claims, as presented by County Auditor Jennifer Robison, be paid. Commissioner Traweek seconded the motion and the Court voted 3-0 to approve. (Exhibit #10)
