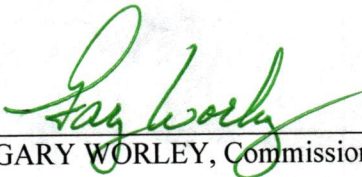

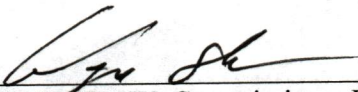
**AFFIDAVIT**

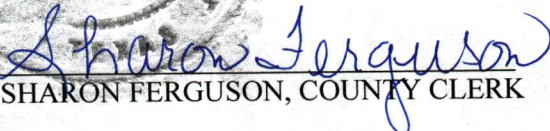
