The Brown County Commissioners Court convened in a Regular meeting July 10, 2023, at 9:00 A.M. in the Commissioner's Courtroom, at the Brown County Courthouse, 200 South Broadway St., Brownwood, Texas.

### I. DECLARE A QUORUM AND CALL MEETING TO ORDER

Judge Britton declared a Quorum and called the meeting to order.

The Total Of Funds Under The Care & Custody Of Brown County Treasurer And Auditor's Report For June 2023 was approved after a motion by Commissioner Worley and a second by Commissioner Traweek. The Court voted 5-0 to approve. An Affidavit, with the Report attached, was signed, and prepared for publication, according to Section 114.026 of the Texas Local Government Code. (Exhibit #2)

Commissioner Kelton seconded the motion and the Court voted 5-0 to approve.

#### VII. RESOLUTIONS AND PRESENTATIONS:

A. First Responder Recognition-Fire Chief Ricky Preas of Bangs VFD.

Judge Britton presented the Emergency Management First Responder Commendation Award to the family of Bangs Volunteer Fire Department Fire Chief Ricky Preas, who passed away on June 28, 2023. (Exhibit #5)

# VIII. BUSINESS TO BE DISCUSSED AND CONSIDERED FOR APPROVAL:

A. Consideration and possible approval of action regarding paying L&K Construction \$10,000 to begin the second installment of project at the Oaks. Presented by Pat McLaughlin.

After discussion, with Grants Coordinator Pat McLaughlin, Commissioner Kelton moved that the Court authorize the second request, from L&K Construction, to draw \$10,000.00 towards the continued repair of The Oaks/Rite of Passage project. Commissioner Shaw seconded the motion and the Court voted 5-0 to approve. (Exhibit #6)

B. Consideration and possible approval of action
regarding selection of option from the Texas Bank
Bid. Presented by Gary Worley.

Texas Bank, the Brown County Depository, had two Options for Deposit Service Requirements. After discussion, Commissioner Worley moved that the Court approve Option #1 for a four year term, year 1 rates fixed, years 2-4 variable with interest bearing demand accounts where interest will be paid on all demand deposit accounts on the collected balances greater than \$1,000. Interest will be paid at the end of each statement cycle and fixed rate certificates of deposit, for maturities less than 1 year, the rate will be calculated 13-week T-bill quote less 0.45 bp. Commissioner Traweek seconded the motion and the Court voted 5-0 to approve. (Exhibit #7)

# C. Consideration and possible approval of action regarding the Burn Ban.

After discussion, Commissioner Worley moved that the Court declare that circumstances present in all or part of the unincorporated area of the county create a public safety hazard that would be exacerbated by outdoor burning and that the Court sign an Order Prohibiting Outdoor Burning, for 90 days, unless the restrictions are terminated earlier based on a determination made by the Commissioners Court or the County Judge based on a determination that the circumstances that required the Order no longer exist. Commissioner Traweek seconded the motion and the Court voted 5-0 to approve. (Exhibit #8)

### IX. FINANCIAL

Commissioner Worley moved that the claims, as presented by County Auditor Jennifer Robison, be paid. Commissioner Traweek seconded the motion and the Court voted 5-0 to approve. (Exhibit #9)
