



Commissioner Worley moved that the Court authorize a salary increase for Chad Hallum, part-time road hand for Precinct #1. The hourly rate will be \$14.00 per hour, instead of \$12.00 per hour. Commissioner Traweek seconded the motion and the Court voted 5-0 to approve. (Exhibit #8)
