A RESOLUTION TO: Support the passage of Proposition 9 that will provide a Cost-of-Living Adjustment to Qualifying Individuals receiving a monthly annuity from the Teacher Retirement System of Texas.

WHEREAS; No public school retiree since September 1, 2004 has received a cost-of-living adjustment and with their TRS pension being their primary, if not their only source of income, and

WHEREAS; 29.7 % of TRS annuitants receive less than \$1,000 a month, 16% are female and 96% are not eligible for personal Social Security nor their spousal benefits due to the Windfall Elimination Provision, and

WHEREAS; The passing of Proposition 9 will not create a tax increase because The Texas Legislature has set aside the funds to support this initiative with voter approval; therefore be it

RESOLVED, That the Brown County Commissioners Court encourage the support and passage of Proposition 9 by voting on November 7, 2023, in favor of Texas Retired Public School Retirees.

FACTS

Info taken from <u>A Value for A Texans</u> an August 31, 2022 TRS publication

450,000+ either the actual annuitant or their dependent receive a monthly annuity which is 1 in every 20 Texans are a member of TRS <u>376 are over 100</u>

74.5 % are female most cannot cannot draw Social Security, since only 17 school districts in Texas are fully implemented, no can they get spousal benefits due to the WEP.

<u>96 of ALL TRS ANNUITANTS ARE INELIGIBEL FOR</u> <u>SOCIAL SECURITY</u>

Of that 1.9 B that is paid out annually, 94% is spent locally with 474.6 B in West Texas

In 2022 the total impact of TRS annuities and health care benefits to the state was 47.6 B

From their annuity, every \$1 our retirees spend locally, it stimulates about \$2.35 worth of activity

For every \$1 spent on health care locally, it stimulates about \$3.56 worth of activity

The average monthly annuity for all retirees is \$2,174

29.7% receive less than \$1,000

22.7% receive between \$1,000-\$2,000

22.9% between \$2,000-\$3,000

6% between \$3,000-\$4000

9% receive more that \$4,000
