A. Consideration and possible approval of Order of Special Election to fill unexpired term of Justice of the Peace,

Commissioner Worley moved that the Court declare a Notice Of Special Election to fill the unexpired term of Justice of the Peace, Precinct #1 to be on the General Election ballot for November 5, 2024. Commissioner Kelton seconded the motion and the Court voted 5-0 to approve. (Exhibit #3)

B. Consideration and possible approval of action to declare bottom dump trailer surplus and sell on Govdeals.

Commissioner Worley moved that the Court declare as surplus, to be listed on GovDeals, a bottom dump trailer, (VIN #1TKSC4022w097887) used in Precinct #1. Commissioner Traweek seconded the motion and the Court voted 5-0 to approve.

C. Consideration and possible approval of action to purchase a bottom dump trailer for Pct. 1.

Commissioner Worley moved that he be authorized to purchase a 2024 belly dump trailer, from Bruckner's Truck Sales, Inc., for \$49,345.00, to be used in Precinct #1. The purchase price will be paid from Precinct #1 funds. Commissioner Shaw seconded the motion and the Court voted 5-0 to approve. (Exhibit #4)
