

Commissioner Worley moved that the Court approve a Memorandum Of Agreement Between Brown County and the Federal Emergency Management Agency Integrated Public Alert and Warning System (IPAWS) Program Management Office regarding the use of Brown County Interoperable System(s) and IPAWS OPEN Platform for Emergency Networks (IPAWS-OPEN). Commissioner Traweek seconded the motion and the Court voted 4-0 to approve. (Exhibit #9)

B. Consideration and possible approval of action regarding enrolling Brown County in the Texas Association of Counties Cybersecurity Course. Presented by Shane Britton, County Judge.

Commissioner Worley moved that the Court approve Brown County's participation in the Texas Association of Counties Cybersecurity Course Enrollment for all county employees, elected officials, and appointed officials who have access to a local government computer system or database to complete an annual cybersecurity training that has been certified by the Texas Department of Information Resources. (DIR). Commissioner Shaw seconded the motion and the Court voted 4-0 to approve. (Exhibit #10)

C. Consideration and possible approval of IT Hardware Recycling. Presented by Goldsmith.

Commissioner Shaw moved that the Court authorizes Goldsmith Solutions, IT, to recycle old used Brown County hardware, as presented by David Sons from Goldsmith Solutions. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve. (Exhibit #11)
