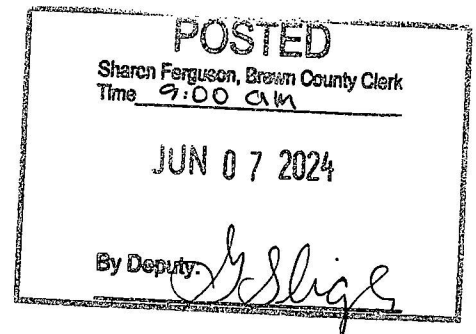


After discussion, no action was taken.


