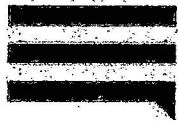

Below is the quote for Control Center. Also, attached are the FAN request forms for the FirstNet Extended Primary account build. We will need these for eligibility, and it usually takes 5-7 business days for this to come back.

Please read through the details below and reply all with "approved" so that the team can move forward with next steps in setting up your AT&T Control Center platform for FN Extended Primary for Brown County.

AT&T is providing information below for our Control Center platform for Brown County. Included are details on data service pricing and next steps for the process of setting up Control Center account.

- Next steps is to approve this email and then an Implementation Manager (IM) will be assigned to your account and the Control Center build will be established. It normally takes 2-3 weeks to complete this process
- After the onboarding process the portal will be available and you will be provided training and be able to order FirstNet Control Center SIMs for use. The SIMs ordered through the portal are specific to the Control Center platform and will be inventoried accordingly

In addition to the Monthly Recurring Costs, we have the following, which have been reduced/waived as follows:

- -SIM & Activation: \$0.00/Standard SIM & \$0.00/Activation (normally \$2.00 respectively)
