Attached is paperwork regarding the Museum's request for the 2024/2025 budget.

We respectfully request \$18,000.

All the funding goes directly to help maintain and operate this County Museum. Over 3,400 school children, out-of-town visitors, and local citizens visited and attended educational programming at the Museum this past year. This number is currently projected to be increased by the end of the year.

The Brown County Museum of History has proudly served our community for over 40 years as the main place where our local history is preserved. A large portion of the history regarding our pioneers, frontier law enforcement, and World War II would be lost if the Museum was not here. Therefore, this institution is an excellent source in contributing to the historical preservation of our county.

The Museum has wide support with local donors and volunteers, and fundraising efforts are always underway since the Museum works hard to not only sustain but to hopefully grow, providing more opportunities for preservation, educational and creative exhibitions and programs. We do, however, require your help since we keep admission and special event prices low to better serve the whole community, including many children, regardless of income level. We strive to provide programs that reflect on our institution as a cultural achievement for our community, a place expressing the heritage and legacy of our county and its citizens.

Having a strong patronage from you, our County officials, also aids us as we seek donors and grants for the Museum of History, a county entity.

To Be Used As Follows:

\$3,800	Annual	usage of electricity	for the	Historic Jail	

- 1,200 Water/Trash Utilities for Old Jail
- 3,300 Staff cost for assistant/tour guide of the Old Jail (roughly 19% of their salary)
- 500 Supplies for maintaining Old Jail and artifacts: i.e. cleaning supplies; office supplies, etc.
- 2,500 Children's Educational Programs and school tours.
- 2,100 Law Enforcement Exhibits at the Old Jail
- 4,900 Portion of annual usage of electricity at the Museum's main building
