Dear Judge Britton and Brown County Commissioners:

The intent of this letter is to request a subsidy from Brown County for \$7500 for the 2023-24 budget year. These funds will be used in our Direct Aid program to assist approximately 150 families with utilities and rent. We also assist with obtaining birth certificates and ID's which help when applying for jobs and securing permanent housing. Only clients who have not received financial assistance from Good Samaritan Ministries in the past two years will be assisted with these funds.

As a non-profit requesting taxpayer funds, we understand the concern some may have about how we use these monies. A careful look at the color-coded Vendor Report shows that our Direct Aid funds were paid directly to landlords, utility companies, the Brown County Clerk's office, Texas Department of Public Safety and other providers. The funds we are requesting are deposited under #10700 Direct Aid on our balance sheet. The amounts we paid to the various financial assistance providers can also be seen on our financials under Financial Aid: Electric/Gas Assistance (61300), Rent/Housing Assistance (61700) and Water Utility Assistance (61900). None of the funds we received from Brown County in your last fiscal year went to directly to clients, nor were they used for any other purpose at Good Samaritan Ministries.

The Vendor Report shows a transaction summary of the clients we were able to assist from October 1, 2022, through June 30, 2023. We appreciate your sensitivity to client confidentiality. A record of each vendor, the type of assistance and the amount are listed. Enclosed you will also find, a Balance Sheet and Income/Expense statement from FY 2022. Our financial statements are reviewed monthly by Kathryn Isbell, CPA.

Good Samaritan Ministries has been providing limited financial assistance to needy families in Brown County since 1993. We have been blessed to receive grant funding from Brown County to help provide indigent financial assistance for many years. We hope that you will continue allowing us to work with you to serve "the least of these" in our community.

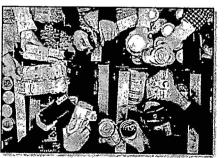
