

After discussion, with Angie Dees, Director of the Brownwood Senior Citizens Program, Commissioner Kelton moved that the Court adopt a Resolution certifying that the County has made a grant to City of Brownwood Senior Citizens Center, that will allow the County to apply for its share of a grant from the Texas Department of Agriculture to assist with financing a home-delivered meal program that provides meals to home bound persons in the County who are elderly and/or have a disability. Commissioner Worley seconded the motion, and the Court voted 5-0 to approve. (Exhibit #3)

After discussion with Sheriff Vance Hill, Commissioner Worley moved that the Court approve the Schedule of Brown County Sheriffs' Service Fees proposed for 2025 with one change, being the housing inmates for other counties/agencies (per day/per head) fee to go from \$65.00 to \$75.00. Commissioner Traweek seconded the motion, and the Court voted 5-0 to approve. (Exhibit #6)
