

The Brown County Commissioners Court convened in a Special meeting on September 24, 2024, at 9:00 A.M. in the Commissioner's Courtroom, at the Brown County Courthouse, 200 South Broadway St., Brownwood, Texas.

## I. DECLARE A QUORUM AND CALL MEETING TO ORDER

Judge Britton declared a Quorum and called the meeting to order.

F. Consideration and possible approval of County Attorney office space annex and lease terms for a building located at 600 North Fisk Avenue. Presented by County Attorney Jennifer Broughton.

After discussion with Brown County Attorney Jennifer Broughton,

Commissioner Kelton moved that the Court approve an Office Lease Agreement between Kirk Chastain and Brown County for property located at 600 North Fisk Avenue, Brownwood, TX. The property will be the new location for the Brown County Attorney's Office. The lease will be for 5 years at \$1,200.00 per month. Commissioner Traweek seconded the motion, and the Court voted 5-0 to approve. (Exhibit #8 for September 23, 2024)

A. Public Hearing to Consider Brown County Government's Fiscal Year 2025 Budget.

Judge Britton opened the public hearing on the Brown County Government's Fiscal Year 2024/2025 Proposed Brown County Budget at 9:12 a.m. and asked for questions or comments. There were none. Judge Britton closed the public hearing at 9:14 a.m. on the Brown County Government's Fiscal Year 2024/2025 Proposed Brown County Budget.

B. Public Hearing to Consider Salaries of Elected County and Precinct Officers within Brown County Government's Fiscal Year 2025 Budget.

Judge Britton opened the public hearing on the 2024/2025 consideration of salaries of Elected County and Precinct Officers within the Brown County Government's Fiscal Year 2024/2025 Budget at 9:14 a.m. He asked for questions or comments. There were none. Judge Britton closed the public hearing on considering the salaries of Elected and Precinct Officers within the Brown County Government's Fiscal Year 2024/2025 Budget at 9:15 a.m. C. Public Hearing to Consider Brown County Government's tax rate for Tax Year 2024.

Judge Britton opened the public hearing on the Brown County Government's Proposed Tax Rate for Tax Year 2024/2025 at 9:15 a.m. He asked for questions or comments. There were none. Judge Britton closed the public hearing on the Brown County Government's Proposed Tax Rate for Tax Year 2024/2025 at 9:16 a.m.

## V. BUSINESS TO BE DISCUSSED AND CONSIDERED FOR APPROVAL:

A. Consideration and possible approval of Brown County Government's Fiscal Year 2025 Budget.

Commissioner Worley moved that the Court adopt the Brown County Government's Fiscal Year 2024/2025 Budget. The budget will raise more revenue from property taxes than last year's budget by an amount of \$871,792.00 which is a 4.68 percent increase from last year's budget. The property tax revenue to be raised from new property added to the tax roll this year is \$329,710.00. Commissioner Shaw seconded the motion, and the Court voted as follows:

B. Consideration and possible approval of Salaries of Elected County and Precinct Officers within Brown County Government's Fiscal Year 2025 Budget.

Commissioner Kelton moved that the Brown County Elected County and Precinct Officers within Brown County Government's Fiscal Year 2024/2025 Budget will receive a 5% raise, across the board. Commissioner Traweek seconded the motion, and the Court voted as follows:

Shane Britton, County Judge-aye Gary Worley, Commissioner Precinct 1-aye Joel Kelton, Commissioner Precinct 2-aye Wayne Shaw, Commissioner Precinct 3-aye Larry Traweek, Commissioner Precinct 4-aye All Brown County employees received a salary increase. C. Consideration and possible approval of Brown County Government's tax rate for Tax Year 2024.

Commissioner Worley moved that the Court adopt, by Resolution, the Brown County Government's tax rates for Fiscal Year 2024/2025 as proposed:

<b>General Fund Rate</b>	0.37702
Debt Service Rate	0.02296
<b>Road and Flood Rate</b>	0.07202
Total Tax Rate	0.47200

Commissioner Shaw seconded the motion, and the Court voted as follows:

This tax rate will effectively raise more taxes for maintenance and operations than last year's rate by 4.68%. This year's levy to fund maintenance and operations expenditures exceeds last year's maintenance and operations tax levy. (Exhibit #2) **D.** Consideration and possible approval to adopt Brown County Government's Maintenance & Operations Tax Rate for Tax 2024.

Commissioner Worley moved that the Court adopt the Brown County Government's Maintenance & Operations Rate for Fiscal Year 2024/2025 of 0.37702 per \$100.00 valuation. Commissioner Shaw seconded the motion, and the Court voted as follows:
