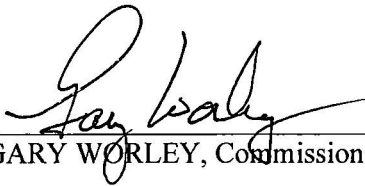

AFFIDAVIT

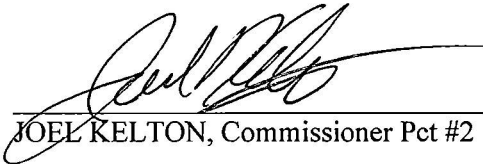
