

After discussion with Sheriff Vance Hill, Commissioner Kelton moved that the Court approve an Interlocal Cooperation Agreement For County Jail Functions between Brown County and Mills County for the holding and incarceration of Brown County prisoners, in Mills County, at the rate of \$75.00 per day. Commissioner Traweek seconded the motion, and the Court voted 4-0 to approve. (Exhibit #4)

B. Consideration and possible approval of an interlocal cooperation agreement between Brown County and San Saba County for the housing and detention services of inmates. Presented by Sheriff Vance Hill.

Commissioner Traweek moved that the Court approve an Interlocal Cooperation Agreement For County Jail Functions between Brown County and San Saba County for the holding and incarceration of San Saba County prisoners at the rate of \$75.00 per day. Commissioner Kelton seconded the motion, and the Court voted 4-0 to approve. (Exhibit #5) C. Commissioner Traweek moved that the Court approve an Interlocal Cooperation Agreement For County Jail Functions between Brown County and McCullough County for the housing and incarceration of McCullough County prisoners at the rate of \$75.00 per day. Commissioner Kelton seconded the motion, and the Court voted 4-0 to approve. (Exhibit #7) E. Commissioner Worley moved that the Court authorize an additional \$12,000.00 yearly salary increase for Assistant District Attorney Cara Landers to be paid from SB 22 Funds. Commissioner Kelton seconded the motion, and the Court voted 4-0 to approve.

G. Consideration and possible approval of action regarding approving Bond for Tax Assessor Collector Christine Pentecost. Presented by Sharon Ferguson, County Clerk.

Commissioner Traweek moved that the Court approve the Comptroller's Bond for Tax Assessor Collector Christine Pentecost. Commissioner Kelton seconded the motion, and the Court voted 4-0 to approve. (Exhibit #8) H. Consideration and possible approval of an agreement between Brown County and the Department of Veterans Affairs for the return of a van bought by Brown County and donated to the VA. Presented by Shane Britton, County Judge.

Commissioner Kelton moved that the Court approve an Agreement Between The Department Of Veterans Affairs (VA) And The Brown County, Texas Volunteer Transportation Network for the return of a van that's condition makes it unacceptable for use in the Volunteer Transportation Network or it is no longer needed for use. Commissioner Traweek seconded the motion, and the Court voted 4-0 to approve. (Exhibit #9)

Commissioner Traweek moved that the Court approve a Lease Agreement between the City of Brownwood, Texas and Brown County, Texas for the lease of the Pecan Valley Domestic Violence Shelter, Inc., d/b/a The Ark for a period of 10 years beginning January 1, 2024. Commissioner Kelton seconded the motion, and the Court voted 4-0 to approve. (Exhibit #10) J. Consideration and possible approval of lease agreement between Brown County and the City of Brownwood for the Veteran Services Office located at 2600 Memorial Park, Brownwood, Texas. Presented by Shane Britton, County Judge.

Commissioner Kelton moved that the Court approve a Lease Agreement between the City of Brownwood, Texas and Brown County, Texas for the lease of the Veteran Service Office located at 1600 Burnet Drive, Brownwood, Texas for a period of 10 years beginning January 1, 2025. Commissioner Traweek seconded the motion, and the Court voted 4-0 to approve. (Exhibit #11)

K. Consideration and possible approval of a contract between Brown County and Tyler Technologies, Inc. for case management, court management, law enforcement and financial software. Included within the approval is the authorization for the County Judge to sign the necessary contract. Presented by Shane Britton, County Judge.

After discussion, Commissioner Worley moved that the Court approve a Software As A Service Agreement between Brown County, Texas and Tyler Technologies, Inc. for Case Management, Court Management, Law Enforcement and Financial software for all Brown County offices for an amount not to exceed \$2,326,664.00 and authorize the County Judge to sign the Contract. Commissioner Traweek seconded the motion, and the Court voted 4-0 to approve. (Exhibit #12) L. Discussion regarding the upcoming vacancy in the office of the Brown County Constable, Precinct 1. Presented by Shane Britton, County Judge.
