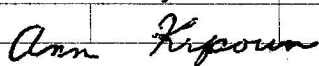
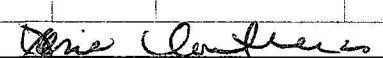

AFFIDAVIT

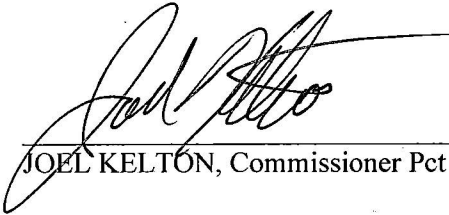
