# VIII. BUSINESS TO BE DISCUSSED AND CONSIDERED FOR APPROVAL:

A. Consideration and possible approval of Brown County's FY 25/26 Budget. The Court reconvened at 6:00 P.M. to consider the Brown County FY 2025/2026 Budget. After discussion, Commissioner Kelton moved that the Court adopt the Brown County Government's Fiscal Year 2025/2026 Budget. This budget will raise more revenue from property taxes than last year's budget by an amount of \$1,215,011.00 which is a 6.42 increase from last year's budget. The property tax revenue to be raised from new property added to the tax roll this year is \$288,935.00. Commissioner Chastain seconded the motion, and the Court voted as follows:

B. Consideration and possible approval of Brown County elected official's salaries for FY 25/26.

Commissioner Reid moved that the Brown County Elected County and Precinct Officers within Brown County Government's Fiscal Year 2025/2026 Budget will receive a 5% raise, across the board. Commissioner Chastain seconded the motion, and the Court voted as follows:

All Brown County employees received a salary increase.

C. Consideration and possible approval of Brown County's tax rate for Tax Year 2025.

Commissioner Kelton moved that the Court adopt, by Resolution, the Brown County Government's tax rates for Fiscal Year 2025/2026 as proposed:

General Fund Rate 0.39624

Debt Service Rate 0.02385

Road and Flood Rate 0.07473

Total Tax Rate 0,49482

Commissioner Reid seconded the motion, and the Court voted as follows:

This tax rate will effectively raise more taxes for maintenance and operations than last year's rate by 4.83%. This year's levy to fund maintenance and operations expenditures exceeds last year's maintenance and operations tax levy. (Exhibit #3)

D. Consideration and possible approval to adopt Brown County's Maintenance & Operation Tax Rate for Tax Year 2025.

Commissioner Traweek moved that the Court adopt the Brown County Government's Maintenance & Operations Rate for Fiscal Year 2025/2026 of 0.39624 per \$100.00 valuation. Commissioner Kelton seconded the motion, and the Court voted as follows:
