have a disability. Commissioner Reid seconded the motion, and the Court voted 4-0 to approve. (Exhibit #1)

After discussion with Sheriff department's Captain Les Karnes, Commissioner Chastain moved that the Sheriff Department we authorized to accept a bid from NCIC Correctional Services for the Sheriff Department's Inmate Telephone System. Commissioner Traweek seconded the motion, and the Court voted 4-0 to approve. (Exhibit #4)
