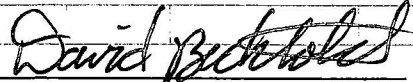
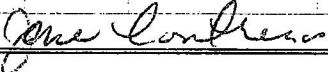

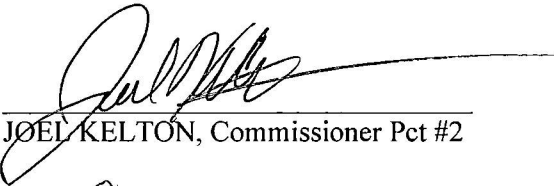
AFFIDAVIT
