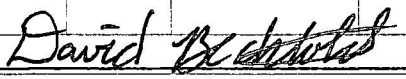
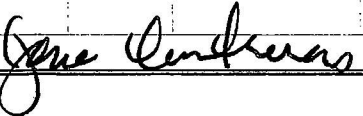

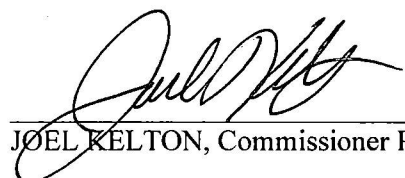
AFFIDAVIT

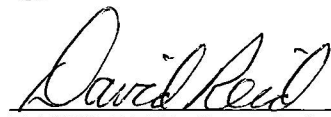

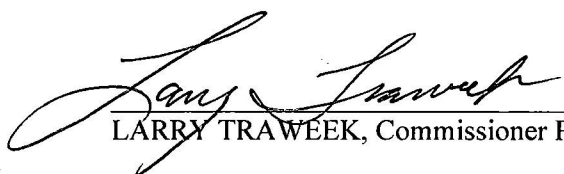
