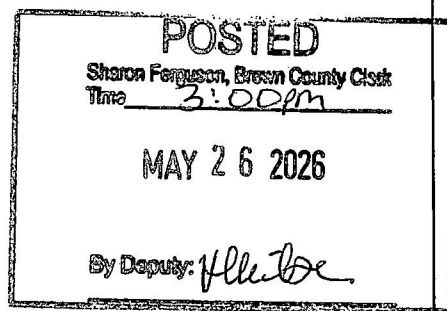

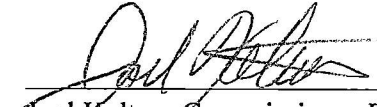

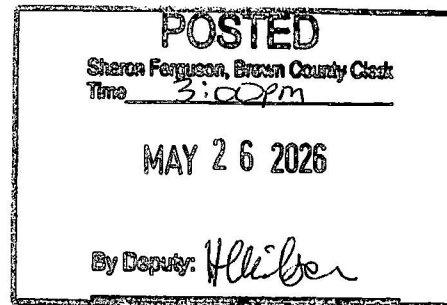

- a. Update regarding the office of Brown County Auditor, by Mike Smith, 35th District Judge.**

District Judge Mike Smith read a letter, from Brown County Auditor Jennifer Robison, announcing that she will be resigning her position as the Brown County Auditor effective May 31, 2026. District Judge Mike Smith informed the Court that the current Brown County Assistant County Auditor, Josie Contreras, will serve as Interim Brown County Auditor until August 1, 2026, when Judge Smith will appoint a new Brown County Auditor.

The June 1, 2026, Combined Statement Of Cash Position was presented by Brown County Treasurer David Beckett, for filing. (Exhibit #1)

- ### **V. BURN BAN: Consider and take appropriate action regarding the county-wide burn ban.**

After discussion, no action was taken. The burn ban remains lifted.

**VI. BUSINESS TO BE DISCUSSED AND CONSIDERED FOR
APPROVAL:**

- a. Consideration and possible approval of Application to Install Private Line on CR 404 by Zephyr Water Supply Corporation. Presented by David Reid, Commissioner Precinct 2.**

Commissioner Reid moved that an application, made by Zephyr Water Supply Corporation, to install a water line within the right-of-way of County Road #404, in Precinct #3 be approved; subject to Brown County specifications for cutting a road. Commissioner Traweek seconded the motion, and the Court voted 4-0 to approve. (Exhibit #2)

- b. Consideration and possible approval of Application to Install Private Line on CR 295 by Zephyr Water Supply Corporation. Presented by David Reid, Commissioner Precinct 2.**

Commissioner Reid moved that an application, made by Zephyr Water Supply Corporation, to install a water line within the right-of-way of County Road #295 in Precinct #3 be approved; subject to Brown County specifications for cutting a road. Commissioner Traweek seconded the motion, and the Court voted 4-0 to approve. (Exhibit #3)

- c. **Consideration and possible approval for County Judge Pro-Tem to execute Cooperative Agreement between Brown County and Pecan Bayou Soil & Water Conservation District #553 for the Texas A&M Forest Service Community Wildfire Defense Grant Program. Presented by Cy Tongate, Pecan Bayou SWCD.**

After discussion with Jewel Richmond, representing the Pecan Bayou Soil & Water Conservation District #553 and Cy Tongate, Program Specialist for the Pecan Bayou SWCD, Commissioner Chastain moved that the Court approve a Cooperative Agreement For Community Wildfire Defense Grant Program County Road Right-Of-Way Fuels Mitigation between Pecan Bayou Soil & Water Conservation District #553 and Brown County, Texas. Commissioner Reid seconded the motion, and the Court voted 4-0 to approve. (Exhibit #4)
