him by law as the aforesaid officer, and shall ⁴

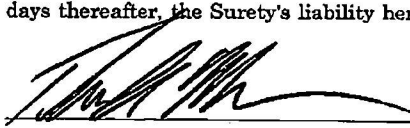
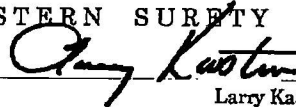
pay all money that comes into his hands as county judge to the person or officer
